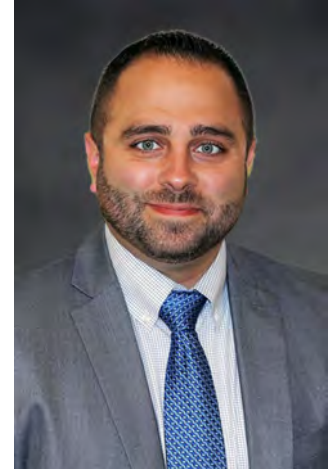
PCCF Board Service Recognized

PCCF Hosts Tax Clinic

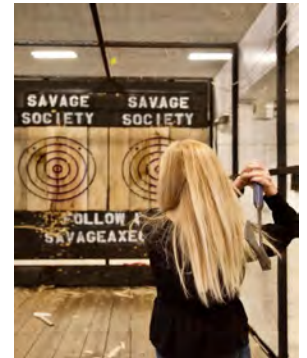
